CREDIT TERMS

- 1) The Applicant agrees to be bound by these Credit Terms and the Sales Terms and Conditions of Electrotraders Enterprises Pty Ltd ACN 675 599 694 (**Electrotraders Enterprises**) in connection with Electrotraders Enterprises's supply of goods and services to the Applicant on a Credit Account.
- 2) These Credit Terms are to be read in addition to the Terms and Conditions of Sale which are available on the website www.electrotraders.com.au
- 3) The applicant authorises Electrotraders Enterprises to make enquiries in relation to the Applicant's commercial creditworthiness including, but not limited to, obtaining reference or reports from credit reporting agencies, trade suppliers, credit providers and trade insurers.
- 4) The applicant authorises Electrotraders Enterprises to disclose (if necessary) the part or whole of the information provided within this Credit Application, along with any information created or collected during our trading relationship, to credit reporting agencies to add to or create any credit information file or database in relation to the Applicant.
- 5) Electrotraders Enterprises may use the personal information provided in this Credit Application, along with any personal information Electrotraders Enterprises collects about the Applicant and the Directors/Partners/Owners (taken together to be the '**Principals**') of the Applicant, to obtain a credit report from a credit reporting agency containing commercial credit information about the Applicant or Principals, or to exchange information with other credit providers about those individuals in the case of any default. The Information received will be used for the purpose of assessing this Credit Application and for managing our ongoing trading relationship. Electrotraders Enterprises may also use the personal information supplied and collected for the purposes of managing purchase orders, payments and communicating with your representatives about our products and services.
- 6) Subject always to Electrotraders Enterprises being satisfied with the Applicant's ability to meet the credit requirements of the Credit Account, Electrotraders Enterprises agrees to advance goods to the Applicant in accordance with these Credit Terms and the Terms of Conditions of Sale and grants the Applicant the Credit Account contemplated by this Application.
- 7) By applying for a Credit Account with Electrotraders Enterprises, the Applicant acknowledges and agrees that upon the issuing of a tax invoice by Electrotraders Enterprises to the Applicant for any goods supplied, the Applicant will have a thirty (30) day payment term to make payment in full of the tax invoice to Electrotraders Enterprises in accordance with the payment method set out on the tax invoice.
- 8) Electrotraders Enterprises may at any time and in its absolute discretion, suspend or withdraw credit from the Applicant or refuse to supply any goods, without prior notice to the Applicant.
- 9) If the Applicant breaches the terms of its Credit Account and/or the Terms and Conditions of Sale then Electrotraders Enterprises may in its absolute discretion terminate the Applicant's Credit Account and rely on the recovery provisions in the Terms and Conditions of Sale with respect to any unpaid amounts/goods.
- 10) The person signing this Application warrants that he/she is authorised to sign this document on behalf of the Applicant.
